
Permission to M.D.(Hom.) Course.

With reference to your letter No.4260 dated 13.2.2001 on the subject cited above, I am directed to say that the matter has been considered by the P.G.Education Committee of this Council in its meeting held on 14th July, 2001. The P.G.Education Committee noted improvements from the report of inspection undertaken by the inspectors on 15.6.2001 in respect of Kaka Saheb Mhaske Homoeopathic Medical College, Ahmednagar and it recommended to allow six admissions in each of Materia Medica, Homoeopathic Philosophy and Repertory subjects for the session 2001-2002 after the institutions gets affiliation for M.D.(Hom.) 


Sir,
